

WHY ARE WE DOING THIS? Background Studies OKC Selected by USDOT Defining the Jargon

• Central OK Fixed Guideway Plan - '05



• OKC Selected by USDOT

- October 2014 USDOT requested agencies to submit Letters of Interest for possible selection as a "Beta Test" agency for a newly proposed transportation policy initiative
 - Health and Transportation Corridor Planning Framework
- November 2014 Letter of Interest submitted
- January 2015 OKC selected!
- Beta Test to be completed fourth quarter 2015





Project Approach

- Established an Advisory Focus Group
 - Membership consists of:
 - Private Sector entities in and near the corridor
 - Public Sector entities in and near the corridor
 - Non-Profit entities in and near the corridor
 - Health Sector entities in and near the corridor
 - Meet with the Advisory Focus Group five times during the planning process
- Established an Advisory Focus Group Health Subcommittee
 - Focused on Health issues and considerations









WHAT ARE THE GOALS? Transportation Health

- OKC City Council Priorities for 2015-2016
 - NW Corridor directly addresses two of the six priorities
 - Develop a transportation system that works for all citizens
 - Enhance recreation opportunities and community wellness

- Developed Goal Statements Transportation
 - Improve multimodal options
 - Support private investment as well as economic development, revitalization and land use redevelopment opportunities for the corridor
 - Enhance quality of life and livability
 - Educate the community about benefits of improved multimodal options

• Developed Goal Statements - Health

- Increase people's physical activity achieved during everyday trips.
- Improve access to health-related resources along the corridor.
- Improve air quality and other health-related natural environmental conditions.
- Expand the equitable benefits of healthy, safe access to transit for transportationdisadvantaged populations.
- Increase the safety of pedestrians and cyclists along and crossing the corridor and/or accessing transit there.













23rd Street Potential Stop Area: Existing Sidewalk Grid




23rd St and Classen Blvd Potential Multi-Modal Node: Existing Transit Connections




23rd St and Classen Blvd Potential Multi-Modal Node: Jobs + Population Per Acre Density




23rd Street Potential Stop Area: Pedestrian Safety Concerns




23rd Street Potential Stop Area: Bicycle Safety Concerns














